### **Notice Regarding Acquisition of SBTi Certification**

KAWADA TECHNOLOGIES,INC. (the “Company”) hereby announces that it has recently obtained certification from the Science Based Targets initiative (“SBTi”) for the Group’s greenhouse gas (GHG) emissions reduction targets.

#### **1. Overview of SBTi**

SBTi is a collaborative initiative established in 2015 by CDP, the United Nations Global Compact (UNGC), the World Resources Institute (WRI), and the World Wide Fund for Nature (WWF). SBTi verifies and certifies the validity of GHG emissions reduction targets set by companies, ensuring they align with the levels required by the Paris Agreement, which aims to keep the global temperature rise well below 2°C above pre-industrial levels and to pursue efforts to limit the temperature increase to 1.5°C.

## 2. Acquisition of SBTi certification

The Company formulated the following GHG emissions reduction targets on October 10, 2025, and submitted an application for certification. These targets were certified by SBTi on December 17, 2025 as being aligned with the levels required by the Paris Agreement and based on scientific evidence.

### Certified targets

Scope 1 and Scope 2	By the end of FY2030, reduce total greenhouse gas emissions by 42% compared to the results of FY2022.
Scope 3 Category 1	By the end of FY2030, reduce total greenhouse gas emissions by 25% compared to the results of FY2023.

## 3. Future initiatives

The Company regards the recent acquisition of SBTi certification as a significant opportunity and will vigorously promote specific emissions reduction measures across the entire Group to achieve the certified GHG emissions reduction targets. In Scope 1 and Scope 2, the Company will promote energy efficiency while also aiming to expand fuel conversion and electrification, as well as the adoption of renewable energy. In Scope 3, the Company will promote strengthening collaboration across the entire supply chain and environmentally conscious procurement. Under the leadership of the management team, the Company will establish a company-wide promotion structure and strengthen effective governance by thoroughly managing and evaluating progress. The Company will disclose the progress of these initiatives with transparency and deepen collaboration through dialogue with the various stakeholders. By strengthening the ability to respond to climate change risks and creating new business opportunities, the Company aims to contribute to the sustainable enhancement of corporate value.
